# Chapter 1: Introduction and Background

## 1.1 Introduction

The **Official Languages Act 2003** provides for the preparation by public bodies of a language scheme detailing the services which they will provide:

- through the medium of Irish,
- through the medium of English, and
- through the medium of Irish and English

and the measures to be adopted to ensure that any service not currently provided by the body through the medium of the Irish language will be so provided within an agreed timeframe.

In accordance with section 14(3) of the Act, language schemes remain in force for a period of 3 years or until such time as a new scheme is confirmed by the Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media, whichever is the later.

## 1.2 Preparation and Content of the Scheme

In the preparation of this scheme, due regard has been given to the Guidelines issued by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. In addition, there has been a comprehensive process of consultation with relevant stakeholders.

The **Kerry Education and Training Board (Kerry ETB)** is guided by the principle that the provision of Irish language services should be based on:

- the underlying level of demand for specific services in the Irish language,
- the importance of a proactive approach to the provision of such services, and
- the resources, including human and financial resources, and the capacity of the body concerned to develop or access the necessary language capability.

This scheme complements the principles of Quality Customer Service and our Customer Charter. It has been formulated with the intention of ensuring that all relevant obligations under the Official Languages Act by the **Kerry Education and Training Board (Kerry ETB)** will be fully addressed on an incremental basis, through this and future schemes.

The time and effort put in by all concerned in this process is acknowledged and appreciated.

## 1.3 Commencement date of the Scheme

This Scheme has been confirmed by the Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media. It commences with effect from 27 December 2020 and shall remain in force for a period of 3 years or until a new scheme has been confirmed, whichever is the later.

## 1.4 A Note on the Updated Scheme 2020-2023

In the period of time where the previous Language Scheme was in place, certain changes have been made in Kerry ETB's provision of services in Irish:

- i. An Irish Language Officer has been employed on a part-time basis since 2015;
- ii. An Irish Language Steering Committee has been established to direct the Irish Language Officer's work. The committee meets 4 times annually to monitor progress.
- iii. Kerry ETB has developed an Irish language Policy and a Vision for the Irish Language which is published on the website;
- iv. A Further Education and Training Centre opened in Dingle in 2017. This is a centre which is operating in a Gaeltacht area and which affords Kerry ETB more opportunities to provide services to the Gaeltacht community in West Kerry;
- v. Kerry ETB is co-funding Irish language courses in Corca Dhuibhne and in Uíbh Ráthach in conjunction with Oidhreacht Chorca Dhuibhne and Kerry County Council;
- vi. Kerry ETB is co-funding an Irish Education Officer role in Uíbh Ráthach in partnership with Údarás na Gaeltachta;
- vii. Kerry ETB is supporting efforts to source funding for two Youth Officer roles, one in Uíbh Ráthach and one in Corca Dhuibhne;
- viii. Kerry ETB is a member of the Uíbh Ráthach Taskforce, which aims to tackle the population decline in that area through providing a higher level of services to the communities there;
- ix. Kerry ETB provides a range of creative projects in Corca Dhuibhne for children and teenagers through Irish (see Services in the Gaeltacht below);
- x. Kerry ETB has been named as the Lead Organisation for writing the Tralee Language Plan. Tralee has been named a Gaeltacht Service Town and work on the Plan has recently begun.

## **Chapter 2: Overview of Kerry ETB**

**Kerry Education and Training Board (formerly Kerry Education Service – the VEC in Kerry) was established on July 1st 2013. Kerry ETB is a statutory agency with responsibility for the delivery of education and training services in Co. Kerry.**

Kerry ETB is a large organisation with over 1,100 staff, over 4,000 students in full time education, circa 1,200 Further Education and Training courses catering for approximately 11,700 learners and an annual budget of circa €67 million.

### **2.1 Mission and Objectives**

It is the mission of Kerry Education and Training Board, in conjunction with other education and training agencies and community development bodies, to create and promote the development of a lifelong learning society in Kerry, so that all who live in Kerry have access to the education and training required to fulfil their potential and needs.

## 2.2 Main Functions

The general functions of an Education and Training Board, stated under the Education and Training Boards as per Section 10 of the Education and Training Boards Act 2013 are:

- a) establish and maintain recognised schools, centres for education and education or training facilities in its functional area,
- b) when directed to do so by the Minister:
  - i. establish and maintain recognised schools in its functional area,
  - ii. establish and maintain centres for education in its functional area,
  - iii. maintain centres for education or recognised schools in its functional area, and
  - iv. establish, maintain or resource education or training facilities in its functional area,
- c) plan, provide, coordinate and review the provision of education and training, including education and training for the purpose of employment, and services ancillary thereto in its functional area in:
  - i. recognised schools or centres for education maintained by it,
  - ii. education or training facilities maintained or resourced by it,
  - iii. children detention facilities maintained by other public service bodies,
- d) enter into arrangements with, and provide support services to, education or training providers,
- e) establish scholarships,
- f) adopt a strategy statement,
- g) adopt an annual service plan,
- h) cooperate with anybody nominated to carry out internal audit functions,
- i) provide education and training at the request of, and on behalf of, any body which funds training out of money provided to that body by the Oireachtas,
- j) support the provision, coordination, administration and assessment of youth work services in its functional area and provide such information as may be requested by the Minister for Children and Youth Affairs in relation to such support, and
- k) assess whether the manner in which it performs its functions is economical, efficient and effective.

Kerry ETB is active in the local communities through the direct provision of training and education programmes delivered in training centres, colleges and other training and educational centres.

## Chapter 6: Improving Language Capability

### 6.1 Recruitment

The recruitment of staff with the appropriate level of competence in the Irish language in each area of work of Kerry ETB will be the primary means of optimising the availability of services through Irish. Our recruitment policy, which is subject to the framework of agreed national recruitment procedures, will have regard to the need to improve Irish language capability on an incremental basis.

All new staff will be provided with an induction pack containing a copy of our agreed scheme in order to ensure that they are made aware of our commitments under the legislation.

### 6.2 Training and Development

Kerry ETB is committed to making available opportunities for staff to attend appropriately accredited Irish language training courses, as resources permit. All staff will be advised of facilities/opportunities to improve their competency in Irish.

### 6.3 Designated Irish Language Posts

In addition to teachers of Irish, the posts listed below have been designated as having an Irish language competency requirement. It is the intention that holders of these posts will have achieved specified accredited standards in the Irish language, commensurate with the responsibilities of the post. When designating these posts, particular consideration has been given to posts located in Gaeltacht areas and to posts located outside Gaeltacht areas but whose customer base consists largely of Gaeltacht and/or Irish language speaking communities.

## Chapter 7: Monitoring and Review

The responsibility for monitoring and reviewing regularly the implementation of the scheme has been delegated to the **Directorate**. The contact person for the scheme will be the Irish Language Officer of Kerry ETB.

A formal system for monitoring requests for services through Irish will be available and recorded in our Annual Report.

## **Chapter 8: Publicising of Agreed Scheme**

This scheme will be publicised both internally and externally, through a press release initially. A bilingual version of the scheme will be made available on our website and circulated to all staff and appropriate agencies. Other means to publicise the scheme may also be used.

In addition, we will take every opportunity in our day to day interaction with customers to promote and publicise the services we provide in Irish through the following means:

- directly informing customers on a proactive basis of the option of conducting business with us through Irish, for example, by the display of notices at reception areas indicating the Irish language services that are available;
- prominently listing these services on our website;
- signifying on selected guidelines, leaflets and application forms that these documents are also available in Irish, unless presented bilingually;
- giving equal prominence to Irish and English language materials.

A copy of the agreed scheme will be forwarded to the Office of An Coimisinéir Teanga.
