4.1	<p>Standards in Public Office Statement of Interest (SIPO)Forms</p> <p>The Head of Corporate and Procurement reminded Board Members that had not returned their SIPO forms of the need to return them. It was agreed that follow up communications will issue from the Corporate and Procurement Department to relevant Board Members.</p>
4.2	<p>Killarney National Parks and Wildlife Services (NPWS) – see Further Education and Training Report Section 7.2 from May 28, 2024, Board meeting</p> <p>The Board was advised that this matter has been fully addressed. Kerry ETB, on October 9th, 2024, signed a Service Level Agreement (SLA) with the NPWS</p>

	<p>addressing this matter fully, with the agreement of all involved, including staff representative unions.</p> <p>Cllr. Niall Kelleher thanked all involved for finalising matters.</p>
4.3	<p>High Court Summons, Pension Proceedings – <i>see Organisation Support and Development Report Section 7.3 from May 28, 2024, Board meeting</i></p> <p>The Director of OSD advised that there was no further update currently re this matter.</p>
4.4	<p>Kerry College Killarney Campus Building Project – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>The Board was advised that on January 12th, 2024, Kerry ETB submitted the Preliminary Business Case for the FET College of the Future (CoTF) for the development of Kerry College Killarney Campus on the Sara Lee site in Killarney. Members of Kerry ETB’s senior management met with SOLAS in relation to this matter on April 23rd, 2024, where the proposal was reviewed in detail with SOLAS and Department of Further and Higher Education, Research, Innovation and Science (DFHERIS).</p> <p>At the April 23rd meeting the original monetary cost of the site when acquired by Kerry Co. Co. was queried. Kerry ETB were requested to confirm same with Kerry Co. Co. In addition, further feedback at the meeting addressed the need for greater focus on hospitality and the experience economy.</p> <p>Kerry ETB received a letter from SOLAS dated June 11th, 2024, addressing initial feedback from the session on April 23rd, 2024. This communication addressed the need for the refinement of the Preliminary Business Case (PBC), as was being requested by SOLAS nationally to ensure targeted funding under the College of the Future (CoTF) fund. Greater focus on hospitality and the experience economy was required. This letter also addressed the need to establish the original site cost.</p> <p>In terms of the Preliminary Business Case re-submission, two dates were set out for re-assessment, September 2024 and January 2025. SOLAS also committed to providing technical resources to each ETB to assist with the project.</p> <p>In addressing the site valuation matters, in late June 2024 Kerry ETB received confirmation, from Kerry Co. Co., of the relevant figure in respect of the Tailte Éireann site valuation. On July 1st, 2024 SOLAS were formally advised of this figure.</p> <p>Throughout July 2024, communications were ongoing with SOLAS re this matter. An email received on July 15th, 2024 from SOLAS, again addressed the need to establish the original site costs. This email advised that if Kerry ETB could establish</p>

	<p>the site cost with Kerry Co. Co., SOLAS would instruct the ETB to commence the site acquisition process and support its execution.</p> <p>On July 18th, 2024, Kerry ETB received confirmation from Kerry Co. Co. as to the purchase price paid by Killarney Urban District Council for the property in January 2006. This information also was communicated to SOLAS July 18th, 2024, by email.</p> <p>The Board was advised of the Tailte Éireann site valuation and the purchase price paid by Killarney Urban District Council in 2006, these figures were detailed in the CE and Head of TES Board meeting reports. Members noted that the purchase price and valuations remained confidential in accordance with Schedule 3 Paragraph 13 of the Education and Training Boards Act 2013.</p> <p>A further email was received from SOLAS on July 22nd, 2024, addressing the December 2023 Infrastructural Guidelines Strategic Assessment / Preliminary Business Case Process. At a subsequent meeting organised by SOLAS on July 31st, 2024, the requirements of the December 2023 Infrastructural Guidelines Strategic Assessment / Preliminary Business Case Process were reviewed with SOLAS addressing the need for Expressions of Interest (EOI) for site selection.</p> <p>SOLAS was advised by Kerry ETB at the July 31st 2024 meeting, that this site selection process had commenced in May 2021 with Kerry ETB adhering to the provisions of Circular 17/2016, "Policy for Property Acquisition and for Disposal of Surplus Property" and the provisions of Circular 11/15, "Protocols for the Transfer and Sharing of State Property Assets".</p> <p>Following the July 31st, 2024, meeting, CE of Kerry ETB met the Assistant Secretary, Corporate Services and Capital Division, DFHERIS in relation to this matter. At this meeting the CE addressed the site selection process pursued by the ETB (letter dated August 8th, 2024). A summary of the steps taken since May 2021 was attached to the August 8th, 2024, letter.</p> <p>Communications with SOLAS and DFHERIS are ongoing and a further meeting is scheduled with the CE Kerry Co. Co, Wednesday October 30th, 2024.</p> <p>This matter was discussed at length with the following matters noted:</p> <ul style="list-style-type: none"> • The strategic importance to Killarney, Kerry and the South West of this FET College of the Future (CoTF) Campus development • The alignment of the proposed development focused on the hospitality and the experience economy with the local and regional economy needs. • The need to consider learner/student accommodation needs that may emerge <p>Following the discussion re the proposed development, the site, its valuation etc., as per the provisions of the ETB Act Section 12(2)(n) the Board unanimously approved the executive to proceed in engaging with Kerry Co. Co. to progress the</p>

	<p>site acquisition for the figure specified in the Tailte Éireann valuation, subject to Department approval.</p> <p style="text-align: center;">Proposed: Cllr. Niall Kelleher Seconded: Mr. Michael Larkin McCarthy</p> <p>A further update will be provided at the next ETB Board meeting.</p>
4.5	<p>Rent Review for Unit 102, Centrepoint – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>Members were advised that the rent review for Unit 102 memo was to be signed and sealed at the ETB Board meeting on October 29th, 2024.</p>
4.6	<p>Lease (FET) for ‘Ansaldo’- Block F Monavalley – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>In addressing the background to this matter, members were advised that Kerry ETB and previously FÁS has leased this building (since 1998) for use as training workshops. Members were advised that the ETB Board meeting minutes of March 26th, 2024, has a detailed account of this matter.</p> <p>In December 2022 Kerry ETB received communications from Murphy Ramsey Walsh Solicitors and the Landlord (Manor Capital Properties) with the agreed revised lease terms following the lease renewal.</p> <p>The revised terms as agreed in December 2022 were as follows:</p> <ul style="list-style-type: none"> • Annual rent for the property of €50,000 per annum, excluding VAT, plus • €2,500 plus VAT per annum for the land located at the rear of the property • Lease term 15 years with 10-year break clause <p>It was noted that the land at the rear of the building is in use by the Kerry College Monavalley Campus for overhead lines practicals etc.</p> <p>Following Board approval, Kerry ETB submitted the lease to DFHERIS for approval on March 8th, 2023. DFHERIS approval was confirmed by letter of September 21st, 2023.</p> <p>Subsequently in September 2023, prior to finalisation of matters, the landlord advised that they intended to change the terms that were agreed in December 2022 for the use of the land at the rear of the building from €2,500 p.a. to the following:</p> <ul style="list-style-type: none"> • €2,500 per annum for one year, • €7,500 per annum for three years, or • €12,000 per annum for 10 years

	<p>Kerry ETB was not agreeable to this change in the agreed terms. Mediation was suggested by the landlord; however, Kerry ETB did not agree to same as the lease terms had been agreed by all parties and approved by DFHERIS.</p> <p>This matter remains unresolved with further communications received from MRW Solicitors dated July 23rd, 2024, and October 16th, 2024 (as detailed in the Head of Technology, Estates and Sustainability report).</p> <p>The current revised terms proposed by the landlord are:</p> <ul style="list-style-type: none"> • Annual rent for the property of €50,000 per annum, excluding VAT, plus • €2,500 per annum for the land located at the rear of the property for 5 years only • Lease term 15 years with 10-year break clause <p>A further update will be provided at the next Board meeting.</p>
4.7	<p>Gift of Land, Tahilla Community National School – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>Further to this matter, which was addressed at the May 28th, 2024, Board meeting, members were advised that a letter was received on April 18th, 2024 from Tahilla CNS Board of management (BOM) advising their acceptance of the gift of land adjacent to the school from Mr. JG, subject to ETB Board and DE approval.</p> <p>Following review of this proposal at the ETB Board meeting on May 28th, 2024, at the request of the CE, it was agreed to seek DE feedback in relation to the proposal.</p> <p>The letter to the DE, dated September 10th, 2024 sought clarification from the DE regarding the future funding of works on this land given that the school building is leased by the ETB from St. Brendan’s Trust and this land to be gifted to the ETB would be in the ownership of the ETB.</p> <p>This matter remains with the DE. A further update will be provided at the next Board meeting.</p>
4.8	<p>District Court Notice, Kerry College Killarney Admissions Office – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>The Board was advised that this matter has been fully resolved.</p>
4.9	<p>Lease for Lyreacrompane National School (NS) – <i>see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</i></p> <p>The Board was advised that Kerry ETB has agreed with the Diocese of Kerry (St Brendan’s Trust) for the transfer of the patronage of Lyreacrompane NS to Kerry ETB as a Community National School from September 2024.</p>

	<p>Lyreacrompane CNS is Kerry ETB's fourth Community National School (CNS).</p> <p>Work is ongoing addressing the lease terms and when they are finalised the lease will be presented to the ETB Board for approval. It is expected to have matters finalised for the next ETB Board meeting.</p>
4.10	<p>Legal Summons by Infrastructure Investment Fund ICAV acting in respect of its sub-fund, the Valley Healthcare Fund (Head Office Service Charges) – see Technology, Estates and Sustainability Report Section 7.5 from May 28, 2024, Board meeting</p> <p>Members were advised that communications have been ongoing with the Landlord of the Centrepont building (Valley Health Care) re the provisions in the lease for the payment of oil consumption and the application of a blanket 23% rate of VAT on all service charges. These matters arose following the rent review in August 2020 by the new landlord and the landlord had initiated High Court proceeding re these matters, with court proceedings deferred until October 22nd, 2024. Lee Strand Construction and Development Limited were the landlord when the ETB entered the lease in 2015.</p> <p>In line with legal advice, the ETB has agreed to the payment of the oil consumption on a sq. footage basis and the 23% rate of VAT on service charges.</p> <p>The landlord had requested that the ETB sign "side letters" to the lease committing to making these payments for the duration of the lease, avoiding the possibility of any future disputes re same. Kerry ETB engaged with the DE in relation to this request to sign "side letters".</p> <p>Members were advised that following receipt of legal advice and extensive engagement with the DE ETB Financial, Administrative and Personnel Unit, Kerry ETB signed the "side letters" re: oil and service charges on October 18th, 2024.</p> <p>As the signed documentation – "side letters" - were received by the Landlords legal agents in advance of the High Court sitting on October 22nd, 2024, the case was ceased by the landlord at no cost to Kerry ETB. This matter is now fully resolved.</p> <p>Members were advised that the current lease expires in July 2027, with a break clause in July 2025.</p> <p>Related to this matter, the CE advised members that various options for the future of the ETB Head Office had been under consideration by the previous Board. The move to a permanent ETB Head Office remains the preferred solution. The CE referenced the submission made to DE and DFHERIS re the possible acquisition of the MTU South Campus by the ETB. This acquisition proposal remains under consideration and would provide a permanent solution for the ETB Head Office in addition to a reduction in the need for leased FET workshop/training/classroom</p>

	<p>It was noted that the current lease of land to the Company from Kerry ETB is due to expire January 31st, 2047 (30-year lease). A condition of most funding applications is a lease for a minimum of 20 years remaining.</p> <p>As the current 30-year lease has 23 years remaining, it is considered prudent to address extending the current lease term at this time given the level of future development planned and associated timeline.</p> <p>Extending the current lease to 2054 (30 years from 2024) is a Board decision, as per the provisions of the ETB Act 2013 section 12(2)(n).</p> <p>Members were asked to consider this matter which will be presented for approval at the next ETB Board meeting.</p> <p>In addition, members were advised that the Company is purchasing the area of coloured in blue on the map presented. This land purchases is being funded directly by the Company.</p> <p>An Cathaoirleach welcomed the update and the progressive nature of the proposed developments at the Centre.</p>

6.1	<p>Corporate Risk Register update – Information Security Systems Management (Cybersecurity)</p> <p>In line with the provisions of Circular 0002/2019, Provision 7.3, the Director of OSD and Chief Risk Officer Ms. Maria Brennan informed the Board that the Corporate Risk Register has been updated to include Information Security Systems Management as part of the Cybersecurity Baseline Standards. Kerry ETB is currently engaged with the support of IAU-ETB/KOSI in the development of an Information Security Management System. This system will include an ISMS Manual, Risk Assessment, Risk Treatments including Policy Development and Controls.</p> <p>In addition, Kerry ETB have established a Kerry ETB Information Security Management Systems (ISMS) Team to plan and implement the Information Security Management System aimed at protecting the confidentiality, availability, and integrity of information and associated assets from threats and vulnerabilities.</p> <p>Work is ongoing in ICT security policy development informed by a gap analysis. In this regard the following Policies were presented to the Board for approval:</p> <ol style="list-style-type: none"> 1. Firewall Policy 2. Physical and Environmental Security Access Control Policy 3. Desk and Screen Policy for Safeguarding Sensitive Information 4. Framework for development of Policies and Procedures

	<p>The policies as presented by the Director of OSD were approved by the Board.</p> <p style="text-align: center;">Proposed: Ms. Lorraine O’Sullivan Seconded: Cllr. Norma Moriarty</p> <p>It was also noted that the IAU-ETB/KOSI Progress Audit to be conducted November 2024 on Section C1-C3 of the ISMS Manual.</p> <p>Cybersecurity will be a separate standing agenda item for all future Board meetings.</p>
6.2	<p>Kerry ETB Board Meeting Draft Standing Orders – for approval</p> <p>As per the provision of Schedule 3 Paragraph 5 (5), ETB Act 2013 the Board is required to have standing orders in place.</p> <p>Schedule 3, Paragraph 5 (5): Subject to the provisions of this Act every education and training board shall regulate, by standing orders or otherwise, the procedure to be observed and the business to be transacted at its meetings.</p> <p>The Draft standing orders were referenced at the September 10th, 2024, Board meeting and circulated in advance of the meeting for members review and consideration.</p> <p>The Board unanimously approved the standing orders as presented for approval.</p> <p style="text-align: center;">Proposed: Ms. Lorraine O’Sullivan Seconded: Mr. Daniel O’Donoghue</p> <p>PDF copies of the approved and signed standing orders will be circulated to all members.</p>
